Te Kōkiringa Taumata | New Zealand Planning Institute Annual Awards celebrate these projects and the planners leading them with best practice awards in a variety of categories. Best practice awards are made to an individual NZPI Member, or to any organisation, group, or body whose members include an NZPI member. The NZPI Best Practice awards recognise outstanding creativity, innovation, and service. So, if you have a project, no matter how small or large, that is innovative and reflects best practice please take the opportunity to celebrate and share your work and learnings by submitting a nomination to the NZPI Annual Awards

From the winners of these Best Practice categories, the Rodney Davies Project Award and the John Mawson Award of Merit, the Awards Committee select the winner of the Nancy Northcroft Planning Practice Award, NZPI's supreme practice award.

NZPI BEST PRACTICE AWARD: Statutory Planning

This award recognises projects that exemplify excellence in statutory planning.

The category is broad, and may include projects relating to consenting, policy and plan-making, and the innovative development and use of statutory tools, and related research.

ELIGIBILITY

Any NZPI member including student members. If the Statutory Planning was developed by a group, planners must be a predominant part of that group. At least 50% of the planners must be NZPI members or eligible for full membership.

JUDGING CRITERIA;

1. How the project exemplified excellence in the practice of planning.
2. How the project enhanced/could enhance the practice of planning.
3. The central role of planners in the work.

If the Awards Committee select you or your project for a Best Practice Award both the nominee and the award recipient (if different) will be advised confidentially of their success prior to the Awards Presentations. The awards will be presented at the NZPI Annual Conference, which will be held in Kirikiriroa | Hamilton, 20 – 22 March 2024. If you are successful, we encourage you to attend the award presentations and celebrate your success with your peers.

Please note that all decisions made by the Awards Committee are final and discussions will not be entered into.

SUBMISSION REQUIREMENTS:

Please ensure you complete all sections and attach all required supporting material as incomplete nominations will not be accepted.

Applicants must provide:

- a clear and succinct explanation of the Statutory Planning which does not exceed 2 A4 pages.
- A detailed discussion of not more than 1,500 words which describes how the Statutory Planning exemplifies excellence in the practice of planning and addresses the judging criteria.

- An A3 Poster depicting the project
- Text for the Awards citation. Note this must not exceed one-page double-spaced in 12-point Arial font. This material must all be supplied to NZPI no later than 2 weeks prior to the start of the 2024 NZPI Annual Conference. You agree that the material submitted, including the A3 poster and two-minute video, may be used by NZPI to promote the planning profession
