INVESTMENT IN MEMBER SERVICES CONTINUES

2014 has seen NZPI continue investment in membership services through implementation of the strategic direction established in 2013. That investment has not been without cost, but it has contributed to a strong platform upon which NZPI can meet its commitment to empower planners and promote planning excellence in the years to come.

With our vision firmly focussed on recognition as this country's most respected voice in planning, NZPI has been active in contributing to the national conversations around planning issues. That contribution includes numerous meetings with Ministers, Ministry for the Environment officers and other organisations such as the Productivity Commission and Local Government New Zealand. It has also included a greater media presense through radio and TV interviews, countless media releases on issues of the day and the development of submissions and position papers which can inform our discussions. With a major review and amendment of the Resource Management Act on the horizon, NZPI will continue to be proactive in influencing the national debate through a strong media presense, and informed submissions in 2015.

Another large investment in time and resources in 2014 has been the development of a new framework for the Continuing Professional Development (CPD) offered by NZPI. The 2015 CPD programme is testimony to that investment with over 100 tailored courses on offer to members at various levels of complexity. The renewed dedication to CPD and a programme which is more structured keeps faith with NZPI's commitment to promote planning excellence.

In the pages that follow you will find details of other NZPI investments and achievements for 2014 including headlines relating to the membership categories review, NZPI's accreditation programme, the 2014 Award Winners and Distinguished Services Awards recipients, and the highly successful NZPI Queenstown Conference.

POLICY WORK: SUBMISSIONS & POSITION PAPERS

NZPI's policy programme continues to support its members and provide advocacy for planning matters at the international, national and local government levels. NZPI has had increasing engagement with relevant Central Government Ministries and proactively advocating for the planning profession. NZPI's Briefing Paper to incoming Ministers was used as the basis for discussions with the new government, and Ministers whose portfolios have an impact on relevant planning legislation.

In 2014, NZPI released Managing Urban Growth and Freshwater Quality position papers that provide a set of principles to guide responses to critical planning areas. NZPI has continued to advocate for its members through media releases and statements based upon member feedback, and submit on key policy areas such as the Productivity Commission's Using Land for Housing Issues Paper. These papers and submissions are the result of a collaborative, iterative, and robust consultative process undertaken with expertise groups and all NZPI members.

NZPI's increased profile in the policy sphere has led to greater and more frequent engagement with national and local government. The Auckland Branch was asked to lead NZPI's evaluation of the Auckland Unitary Plan process. NZPI has been asked to lead a similar evaluation on behalf of planners for the Christchurch process. In June and July, the Senior Policy Advisor accompanied CEO, Susan Houston, and Learning Manager, John Benseman, on a Branch Roadshow. Visiting each Branch to provide updates on the policy programme and meeting with members remains a crucial part of NZPI knowing, and representing its members.

QUALITY PLANNING PARTNERSHIP

Members of the Quality Planning Partnership recently met in Wellington to celebrate and reaffirm their contractual commitment to the ongoing development of the 'Quality Planning' resource. The successful partnership includes Ministry for the Environment, New Zealand Planning Institute, Resource Management Law Association, New Zealand Institute of Surveyors and Local Government New Zealand.

NZPI ACCREDITATION PROGRAMME IN 2014

NZPI LEARNING CENTRE: CONTINUING PROFESSIONAL DEVELOPMENT

The Learning Centre has developed a strategic plan positioning the CPD programme as the ideal framework for members to equip themselves for their current and future professional roles, whilst being personal, adaptable and appropriate to each member's context and scope of practice. NZPI is committed to delivery, accessibility, recording and achieving of CPD by means of new innovations and education offerings.

Many firsts were achieved in 2014, with the Individual Learning Needs Assessment Survey Tool (ILNAT) forming a robust platform from which to analyse members' current levels of education and identify their CPD needs and product offerings for the programme in 2015 including:

• Re-branding CPD provision according to levels of teaching content, to offer a pathway programme for planners from Graduates to Senior Planners, extended to publicity materials, website and social media content.

• Executive Leadership Programme, launched on the back of the successful Practical Leadership Programme for Emerging Leaders, attracting senior public and private sector planners wishing to develop their personal and professional leadership style, including a microsite complete with resources, forum and thought leadership articles reflecting international best practice.

• Working with external agencies to offer jointly-branded courses and administrative expertise. In 2014, this included Auckland Conversations, Ministry for the Environment and the Environmental Compliance Conference.

• Planning on Demand, a range of eLearning CPD for members in the form of webcasts; recorded interviews and self-paced, independent learning packs.

The Learning Centre is committed to further developing the required infrastructure to support expanded on-demand eLearning and simulation-based CPD.

We have worked this year to broaden the portfolio and create a platform for the expansion of the recording of face-to-face CPD and are encouraged to see a distinct broadening away from traditional CPD to an expanded and diversified use of other educational formats.

The Learning Centre has undergone significant re-organisation to meet the growing needs of the branches, accreditation auditing, managed events and registrations. Several immediate changes put into place to better serve our 2000 members and 11 branches include:

Standardised CPD lexicon – consistent, simplified language in all things CPD i.e.
website, contracts, invoices and marketing
Focused and results-driven marketing and communications via channels, including Planning Quarterly, Planning Focus, email broadcasts and social media
Enhanced online registration, attendance management, CPD auditing tools and branch administration access
Consistent review and feedback to educators on CPD quality and delivery
Pricing review and standardisation per hour across the various delivery channels
Review of CPD accrual criteria, guidelines and audit process.

We are proud to be New Zealand's pre-eminent provider of CPD for planners and will continue to transform ourselves by developing innovations in education for our learners.

PLANNING ON DEMAND

In the year under report NZPI introduced a new initiative called Planning on Demand. The initiative provides members with online CPD opportunities, some of which are free, that they can take up at a time and place of their choosing. The only thing required is internet access. Courses available online through the initiative in 2014 were the highly popular Section 32 training; How to be an Effective Expert Witness; How to become a Full Member of NZPI; an Effective Report Writing course; and a series of interviews from experts in their fields. NZPI will add to that library of online resources in 2015.

PLANNING QUARTERLY

The much applauded Planning Quarterly (PQ) has excelled once again in 2014. PQ's success over the past year is thanks to the Editor, Gina Sweetman, Editorial Panel members Amelia Linzey, Hamish Rennie, Lee Beattie, Sarah Jenkin, James McKibbin, and Clare Wooding, and sub-editor/magazine manager Christina Kaiser.

Ranging from stories on planning and the media to common RMA misconceptions, NZPI's magazine has maintained its quality in look and content despite the considerable decrease in production costs as a result of NZPI's decision to change publishers.

2014 NZPI ANNUAL CONFERENCE

The 2014 NZPI Conference 'Mountains to the Sea' was hosted by the Central Otago Branch against the inspirational backdrop of Queenstown. Featuring international speakers such as Dr Scott McCreary from Berkley, Professor Peter Newman from Curtin University, Rohan Hamden from the South Australian Government and Brent Toderian from the City of Vancouver, the event was both a sell out with 518 delegates in attendance and an outstanding success at many levels, particularly the case studies and debates presented on the themes of Freshwater, Land Use and Adaptation. The pre-conference workshops hosted by the Institute's Special Interest Groups; Elected Representatives, Urban Design Forum, Papa Pounamu Māori Hui and Young Planners Congress were successful in attracting more than 150 delegates combined. The workshops addressed relevant issues encompassing partnerships, cultural practices, design challenges and the latest developments in adventure tourism.

Variety was a key feature of the eight post conference field trips on offer, reinforcing conference themes, speaker insights and conversations within a local context , balanced by the sights and sounds of this tourism hub. The event overall was well received by conference attendees with the conference 'score' at an impressive 4.22 out of a possible 5.0, which is the highest in the 5 years we've been monitoring the event. One of the innovations of the conference this year was the introduction of a smart phone application which enabled delegates to follow the conference and provide feedback on their phones. As a registered Green Event, a number of sustainability initiatives such as waste minimisation and energy conservation were implemented, achieving a 90% waste diversion and a minimisation of carbon emissions to 119 tonnes. The conference offset this impact by partnering with the local tree trust, Te Kakano and planted native trees at a local restoration project. The Conference highlight was the Gala Awards Dinner held at the Skyline Gondola venue atop Bob's Peak. More than 400 guests celebrated planning excellence with their peers, whilst Canterbury members swept five of the 11 awards and Auckland planning consultancy, Campbell Brown picking up the Supreme Award. There was excellent coverage of the conference by Radio NZ, including some comments from Professor Peter Newman, Dr Jan Wright and Hon. Amy Adams.

Mountains to the Sea proved not only to be a success from the point of view of bringing together the brightest of minds in the planning profession, but also for its facilitation of conversations and new thinking on complex issues facing communities today, creating a forum for solutions on key issues facing freshwater, land use and adaption in New Zealand.

2014 ENVIRONMENTAL COMPLIANCE CONFERENCE

The annual Environmental Compliance Conference was well received by regular and new attendees alike, addressing issues comprising of Compliance, Enforcement, Incident Response, Pollution Prevention and Health & Safety. From its new central Wellington location, the conference proved to be very intensive and extremely interesting 2.5 days of presentations and discussions encompassing 54 speakers, 45 sessions and 3 workshops.

Overwhelmingly for the 141 delegates in attendance the highlight was keynote speaker Justice Smith and his address from the bench, with many enjoying new and improved aspects to the program, including Mihi, a field trip to the Transmission Gully Project and a photo competition held during the rambunctious evening dinner function. The winner of the photo competition was Stephanie Growcott-Newbury, Senior Compliance Monitoring and Enforcement Officer, City Planning and Design, Wellington City Council with her neighbours at war submission. The exhibition proved a hit with sponsors, as did the opportunity to network intimately during the breaks with fellow delegates and learn from officers the challenges they faced in in their roles and the solutions they could provide.

This year saw the retirement of popular MC and organising committee member Chris Horan due to secondment to the UK, the committee is grateful for his energy and contribution to a successful 2014 Conference delivering practical know-how and knowledge on being more effective, efficient and up-to-date on Environmental Compliance in New Zealand.

COMMONWEALTH Association of planners

The NZPI has been active in supporting the work of the Commonwealth Association of Planners (CAP) in areas such as resilience planning, other original research and the development of websites for CAP and member countries such as Belize and Ghana throughout 2014. That contribution, which has been at no financial cost to NZPI, was recently recognised with the appointment of NZPI Chair, Bryce Julyan as Vice President for CAP's Australasia Pacific region. "It's a great opportunity to be active in representing and promoting positive planning across the Commonwealth, while at the same time gaining high-level exposure to the latest international thinking on planning issues, which can only help planning in our global region." Said Bryce Julyan. Bryce Julyan commenced his new appointment when he joined seven other CAP Vice Presidents from around the Commonwealth in Singapore in November.

MEMBERSHIP CATEGORIES REVIEW

REGINALD HAMMOND SCHOLARSHIP

The Reginald Hammond Memorial Scholarship Commemorates the first New Zealander to complete a Town Planning qualification which led to him being appointed the first Director of Town Planning in 1926. The scholarship is awarded annually to a worthy recipient in their final year of study for an accredited planning degree at the undergraduate or post-graduate level in New Zealand.

This year's deserved recipient has not only excelled academically whilst supporting himself through University, no small achievement, but he has also recognised the intrinsic rewards of contributing to the wider planning profession.

2013 Reginald Hammond Scholarship: Sebastian Clarke.

RODNEY DAVIES PROJECT AWARD

The Rodney Davies Project Award this year goes to a collaborative project with a focus on water.

Water management within New Zealand has emerged as one of the most significant issues facing both our communities and our profession. The winning project shows the benefits of high quality planning and innovation in responding to that issue.

An options assessment based on community values around water management; a partnership with iwi; and the use of a community led technical advisory group, provided a strong planning foundation that enabled the achievement of 35 year consents for an innovative river recharge scheme. The project provides an outstanding outcome of a 100 year water supply solution for a community. 2013 Rodney Davies Project Award: Kapiti Coast District Council, Te Ati Awa ki Whakarongotai Water Working Group, and CH2M Beca for the Kapiti Water Supply Project.

COMMENDATION FOR RODNEY DAVIES PROJECT AWARD

From time to time the Awards Panel awards a commendation and this has been the case for the 2013 Rodney Davies Project Award.

Following the Canterbury earthquake sequence, the need for innovative solutions and alternative uses within damaged brownfield areas became a necessity. This project represents an outstanding example of brownfield regeneration of industrial land within an area of eastern Christchurch that had historically been in decline and suffered substantial earthquake damage.

The project has seen the restoration of a complex of earthquake damaged buildings with historic values in a manner that retains much of the original heritage fabric and character, whilst concurrently enabling these buildings to be strengthened to meet Building Code requirements, and provide for a range of boutique and tailored commercial spaces to meet modern business needs.

The result is a development which is environmentally and historically sensitive to its location and is having a significant positive social and economic impact on the local and wider community to the point where it is now seen as an attraction for tourist and locals alike.

2013 Rodney Davies Project Commendation: PLANZ Consultants for the Woolston Tannery Development.

LANCE LEIKIS GRADUATE AWARD

The Lance Leikis Graduate Award is awarded for a significant contribution by a Graduate Member of the profession to planning in practice, research, or Institute affairs.

The successful Lance Leikis nominee in 2013 hails from the Canterbury-Westland Branch of NZPI where she has a proven record in making a difference for Young Planners in the region.

Collectively, her passion and actions have been a shining example of how YPs can positively contribute to the profession and practice of planning, both in lifting the profile of YPs and planning in Christchurch.

2013 Lance Leikis Graduate Award: Ms Claire Lindsay.

ALFRED O. GLASSE AWARD

The Alfred O Glasse Award is a rare award for NZPI since it recognises outstanding services to planning by a non-planner. The successful nominee for 2013 also hails once again from the Canterbury Westland region. The Award recognises her 15 years as a City Councillor at Christchurch City Council, and the contribution she made during this time to the planning profession in Christchurch, and New Zealand. Obtaining a gualification as a RMA Independent Commissioner with Chair's Accreditation, she has sat on approximately 1,000 resource consent hearing panels. Her passion and enthusiasm for all things planning related saw her becoming involved with NZPI Conferences where she led and facilitated workshops at NZPI Conferences to enable elected members to come to grips with planning under the RMA and local government.

2013 Alfred O Glasse Award: Ms Sue Wells.





WALLACE ROSS GRADUATE RESEARCH AWARD

In conferring this Award the Panel recognised a PhD thesis as a very well conceived piece of research that addresses a number of the intellectual questions facing planning practice in New Zealand under the Resource Management Act 1991. The winners thesis considers the fundamental and critical question of whether or not district plans are actually delivering their intended planning outcomes in practice, or as part of the development process.

2013 Wallace Ross Graduate Research Award: Dr Lee Beattie.

BEST PRACTICE: EXCELLENCE IN CONSULTATION AND PARTICIPATION PROCESSES

The consultation strategies employed by the winning Project Team of this category were transformative, changing public perception of the Project and enabling a smooth journey through a National Consenting process.

When initially introduced, the Project drew high levels of community opposition. However, over a three year consultation and design process the multi-agency Project Team improved public perception and addressed many of the issues that were initially raised by interested and affected parties so successfully that just 43 submissions were received following notification, only 18 of which were in opposition.


2013 Best Practice Award: Excellence in Consultation and Participation Processes: GHD, BECA and the NEW Zealand Transport Agency for the Christchurch Southern Motorway Stage 2 project.

BEST PRACTICE: COMMENDATION FOR EXCELLENCE IN CONSULTATION AND PARTICIPATION PROCESSES

The Awards Panel received a high quantity and quality of Award nominations. For that reason, the Awards Panel has chosen to confer a Commendation for the Best Practice Consultation and Participation Processes Award.

The winners of the commendation were charged with replacing an iconic piece of infrastructure. To do this, community involvement and applying best practice consultation and engagement from the project's outset was essential. This involved purposeful consultation and engagement that focused on early information gathering, enough time for genuine consultation and engagement and reaching people in a variety of ways sensitive to the diverse community. It included collaboration with community leaders and key stakeholders through a project reference group and workshops with local schools in order to hear what the current and future users had to say about the replacement infrastructure. It also involved managing expectations.

2013 Consultation and Participation Processes Commendation: The New Zealand Transport Agency and Opus for their public engagement around the Old Mangere Bridge.



BEST PRACTICE: EXCELLENCE IN INTEGRATED PLANNING

This Best Practice Award recognises a thoughtfully designed, comprehensive development plan that provides a compact urban form while at the same time recognising and protecting a range of significant natural and heritage features that give the subject site its unique character.

The Institute wishes to recognise the outstanding creativity and innovation that has been demonstrated in delivering this example of best practice planning for a high quality urban environment.

2013 Best Practice Award for Excellence in Integrated Planning: Campbell Brown Planning Ltd for its work on the Sunderland Hobsonville Point Development Plan.









BEST PRACTICE: STRATEGIC PLANNING & GUIDANCE

The recognition of Best Practice continues with the acknowledgement of Excellence in Strategic Planning and Guidance.

The winner of this category has demonstrated a high level of strategy and planning excellence in developing masterplans for a town centre and recreation space.

Picture these challenges– population growth, the need to provide a social and economic heart for the town and wider district and a rapidly changing post earthquake environment.

The response to those challenges are considered by the Panel to have achieved a number of best practice outcomes in planning, recreational planning and urban design. The companion master plans are an excellent example of a collaborative approach to visioning and forward planning, bringing together a range of disciplines and a number of diverse (and conflicting) public and private sector aspirations.

2013 Best Practice Award for Excellence in Strategic Planning and Guidance: Selwyn District Council for its excellent work on the Rolleston Town Centre and Foster Recreation Park Masterplans.

BEST PRACTICE: NON STATUTORY PLANNING

The NZPI Awards Panel consider that the recipient of this award has demonstrated best practice in this innovative and collaborative carbon neutral project.

Global warming, climate change and depletion of the world's natural resources are critical planning issues. The negative effects associated with this warming (such as the increased frequency of severe weather events and the shifting of habitat zones) are placing increasing pressure on biodiversity worldwide.

This world first carboNZero certification achievement has led to significant discussion on the effects of climate change on biodiversity amongst zoo's internationally. As well as being presented on by the CEO of the Zoo, Karen Fifield, at the World Association of Zoos and Aquariums conference in Florida last year, it has also generated discussions at a local level between the Zoo and the local City Council on their carbon emissions goals. The Carbon Neutral project illustrates best practice because it exhibits a new way forward for best management practice for complex problems that is context specific for zoos. It promotes an adaptive learning process rather than a fixed set of rules or guidelines.

2013 Best Practice Award for Excellence in Non Statutory Planning: James Luty of BECA. James was ably supported by the Wellington Zoo Trust, and Enviro-Mark Solutions in planning the Wellington Zoo Carbon Neutral Project.


BEST PRACTICE: DISTRICT AND REGIONAL PLANNING

This Best Practice Award is made for the successful preparation, consultation and adoption of a Land and Water Regional Plan in 2014. This is a regional plan prepared under the Resource Management Act 1991. It was developed and drafted following the passage of the Environment Canterbury Act 2010.

The plan is a great example of the result of a multi-disciplinary staff team working with consultants including planners, scientists, resource managers, hydrologists and engineers.

The Plan is seen to be a robust planning framework for an effects based resource management regime under the RMA. It may be a future model for regional land and water plans elsewhere in the country.

2013 Best Practice Award for Excellence in District and Regional Planning: Environment Canterbury for its work on the Land and Water Regional Plan.





BEST PRACTICE: COMMENDATION FOR DISTRICT AND REGIONAL PLANNING

The commendation recognises excellence in the innovative and technologly savvy review of an Operative District Plan.

The commendation has been awarded to a plan review which attracted over 1,500 submissions, 9,500 submission points, and 37 reports totalling 5,385 pages of evidence presented between September and December 2013. Submitters tabled 7804 pages of evidence.

The robust and inclusive process adopted makes it a worthy recipient of this commendation.

2013 Best Practice Award for Excellence in District and Regional Planning Commendation: Hamilton City Council for its Hamilton City Council proposed district plan review.

BEST PRACTICE: NANCY NORTHCROFT SUPREME BEST PRACTICE AWARD

The Nancy Northcroft Planning Practice Award is the Institute's supreme award for excellence in planning practice.

It is selected by the Awards Panel from the winners of the Best Practice Award across all five categories and the Project Award.

2013 Nancy Northcroft Supreme Best Practice Award: Campbell Brown Planning Ltd for its work on the Sunderland Hobsonville Point Development Plan.

NZPI DISTINGUISHED SERVICE AWARD: ROBERT (BOB) NIXON

Bob has been involved in planning and resource management for over 35 years. His first planning job was with the Housing Corporation in Palmerston North in 1978. Bob then moved to the Ministry of Works in Wellington and Christchurch before becoming District Planner at Paparua County and, following amalgamation, District Planner at Selwyn District.

In 1991 as Team Leader for the new Christchurch City Plan Bob led the preparation of an 'effects based' district plan model under the newly legislated RMA. The Plan was successfully tested in the Environment Court and regarded as a 'pioneering' approach to plan making by MfE.

As one of New Zealand's leading planning thinkers Bob was invited in 1996 by MfE to undertake a review of the 'McShane Paper' on planning practice. At the time planning was under significant attack and Bob's thought provoking work culminated in May 2000 when he was awarded the Institute's prestigious Award of Merit for defending the best principles and practises of planning at national, regional and local levels. Bob subsequently served on Ministerial Working Parties dealing the RMA Amendment Bill and Urban Amenity Values.

In 1999 Bob took a job exchange with the Norwich City Council and in 2002 Bob decided to pursue a career in private practise and joined Planit R.W.Batty & Associates Ltd as a Director.

Over the course of his career Bob has worked on a range of planning projects and Environment Court appeals, however it has been his work in the area of statutory plans and policy documents which has set him apart. Bob has also become a respected Commissioner and has been involved in a number of significant cases including the mammoth 62 day Central Plains Water hearing.

Throughout his career Bob has made a significant contribution to planning practice with his leading role in the cutting edge Christchurch City Plan, his vigorous defence of planning in the late 1990's and his involvement in Institute affairs which include becoming a Full member in 1980, an elected member of the National Council, and acting as the Institute's job exchange liaison person. Bob is therefore a worthy recipient of the NZPI Distinguished Service Award.

NZPI DISTINGUISHED SERVICE AWARD: GINA SWEETMAN

With roles across central and local government and in private practice, as an NZPI Councillor (2006-2012) and as Editor for Planning Quarterly, Gina's contribution to the planning profession in New Zealand is wide-ranging.

She brings detailed technical expertise to her many roles within the planning profession, having been involved in development of amendments to the RMA and acted as a hearings commissioners and chair/facilitator for community groups.

Over and above technical expertise and service to the NZPI, Gina's major strengths are communication and training. Gina has overseen the Making Good Decisions programme and designed and delivered RMA training to councillors and council staff, iwi, and industry groups. This has promoted good practice in planning and resource management decision making. She always has time to share this experience with people who ask and this regard she also regularly provides training for SOLGM on RMA matters and has led their "who's afraid of the RMA" training course. She has the ability to make the complicated seem simple.

Gina is both professionally and personally passionate about the planning issues facing New Zealand today and the role of the planning profession in addressing these issues.



NZPI DISTINGUISHED SERVICE AWARD: STUART KINNEAR

At an age when most people are putting up their feet for a well-earned rest, Stuart continues to make a highly respected contribution to planning practice – 46 years after first beginning his professional career. Stuart is not only a planner, but also a qualified surveyor and was elected a Fellow of the NZ Institute of Surveyors in 1997. It is therefore fitting, if somewhat belated, that the NZPI also recognises Stuart's distinguished service to the planning profession with this award.

Stuart is well respected as a planning practitioner, and more particularly as a hearings Commissioner. He has over 18 years' experience as a Commissioner, either as a panel member or sitting alone. As a Commissioner he has dealt with nearly 70 hearings covering a wide variety of topics and processes - including resource consents, private plan changes and local authority plan development. His integrity and thorough grasp of planning issues continues to be engaged on significant projects, with his latest Commissioner work including Transmission Gully (for the affected councils responding to outline plan and s181 processes), and the ongoing Palmerston North district plan review (a total of nine hearings to date).

Stuart's strengths as a planner include what has been described as an encyclopaedic knowledge of planning, plans, case law, legislation and developments. His surveying and land development background is widely regarded as bringing an extra dimension to his work as a planner. When his professional colleagues search for words to describe Stuart, he emerges as very approachable, a real gentleman, and one of the old school. However, he is also regarded as someone with an iron trap memory, pragmatic, and not one for waffle or unnecessary words.



NZPI DISTINGUISHED SERVICE AWARD: HAYES PERKINS

Hayes is well known and highly regarded as a planner in Auckland having acted in a wide range of roles within both the private and public sector. He has been involved in town planning, resource management and related fields since achieving the qualifications of Bachelor of Science Degree, majoring in Surveying and Mathematics at the University of Otago in 1970, and a Diploma in Town Planning from the University of Auckland in 1974.

Hayes' career started with Andrew Murray and Partners (later to become Murray North Consultants) in 1970 where he worked initially in surveying before a move into planning. His planning work was within both the public and private sectors. Clients included the Auckland Regional Authority and responsibility for planning assessments of environmental impact reports on a range of applications; Onehunga and Glen Eden boroughs and the preparation of the district schemes; and other roles for Auckland boroughs, including One Tree Hill, Waitemata, Orewa and Takapuna. During the 1980s Hayes was also the Acting Borough Planner for Northcote, where he was responsible for preparation of the statement of proposals for the review its district scheme. He also assisted with the preparation of district schemes for Helensville, Waiuku, Mt Roskill, and Papakura and planning advice as required.

Hayes's private sector assistance included land use and subdivision proposals for a range of companies and institutions including BP (NZ), Ministry of Works and Development, Lion Corporation, Railways Corporation and Telecom Auckland. That work also included the preparation of land use and development studies and statistical analysis of urban and regional areas throughout New Zealand.

In 1990, Hayes was the principal consultant in a study for the United Nations Industrial Development Organisation relating to the rehabilitation of an existing industrial estate and the development of a new estate in Honiara on the Solomon Islands. The study included recommendations for development proposals, an administrative structure for the estates and a full financial assessment.

Returning to New Zealand he continued to act as a consultant in the preparation of planning reports on applications for resource consents and preparation of evidence for planning appeals for Auckland City Council. After leaving private consulting in the early 1990s Hayes held a variety of roles within the Auckland City Council working at a senior level in the resource consents area and having an important role in managing appeals and objections. This has involved appearances as an expert witness at the Environment Court. That work has continued through to the current time with the new Auckland Council.

Auckland Council officers, and indeed all that have worked with Hayes, know that his fair, calm and practical approach to planning and working with people has been invaluable to the Auckland City Council and the Auckland Council for over 20 years.

During the course of his distinguished career Hayes has acquired wide experience and developed a high level of expertise in planning which he has been able to direct towards assisting both private and public organisations with a range of town planning and resource management matters. This has always been carried out in an informed, friendly and helpful manner.

One of the features of Hayes's career has been the outstanding mentoring that he has given to planners. He has guided and shaped the careers of many planners and provided the solid foundations to good planning practice. Hayes' calm and unflappable nature has meant he has been well placed to guide and mentor new planners. He has gained the respect of his peers, and has always been in demand by those seeking assistance in planning and resource management processes.

The Institute wishes to recognise Hayes's outstanding mentoring of planners, his energy and enthusiasm, and his significant contribution to the planning profession. We congratulate Hayes on receiving this well-deserved Distinguished Service Award.

The Treasurer outlined the proposed budget, noting that the Board asked the CEO to manage costs to achieve a modest surplus and costs have been trimmed accordingly. The Board advised that 'yes' Board members believed that to be the case but that it would review the issue once again in two years time, noting that there had been a modest increase in subscription fees endorsed by the Board, and that currently the fees were able to be kept at this level with revenue supplemented by conference and CPD (without which fees would need to rise substantially).

Katariana Belshaw thanked the Board, the CEO and the staff of NZPI for their work throughout the year. Katariana's thanks were accompanied by applause from all present.

Nick Aiken congratulated NZPI and the Chair in particular on the increased media profile for planners and planning matters. Alyson Hutton indicated her support for the proposed changes to CPD, especially in the regions.

Dean Chrystal provided an update on the GST issue for Commissioners and encouraged NZPI to continue its involvement.

The Chair conveyed to the meeting Clare Piper's request for the following:

a. The establishment of an Honours Board. The meeting considered and didn't wish to progress this idea as the list is recorded and held by the NZPI and that the "Chains of Office" perform this function.

b. The need to review CPD and in particular costings. The Chair advised that this is already planned as part of the new Learning Manager's role, while noting earlier comments that NZPI revenue is supplemented by the conference and CPD. The current policy will continue with an emphasis on providing accessible CPD.

c. Increased funding of the strategic plan review for Young Planner's. The Chair indicated that the Budget provided sufficient funding for the review to take place.

Wendy Saunders asked that the CPD review also include the development of criteria around the provision of CPD i.e. what criteria must CPD providers meet.

The Chair advised that the membership categories will be reviewed in 2014/15, and that the review will consider where doctorate holders may sit within the new category framework.

FINANCIAL FOREWORD



NZPI was successful in exceeding budgeted income by \$231,042 in 2014. As noted in the annual statements provided by our Accountants and Auditors, NZPI also receipted an additional \$202,637 as income in advance which has not been included in this year's accounts.

Whilst revenue was up, so too was expenditure as the Board continued its commitment to implementation of NZPI's Strategic Plan 2013-2016. A detailed breakdown of the resulting deficit can be found below.

BRANCH INCOME AND EXPENDITURE

Branch income and expenditure are included in the financial statements but controlled and 'owned' by the branches. Since the branches expenditure was \$63,185 and their income only \$41,177 this added an additional \$22,008 to NZPI's loss for the year.

ACCOUNTANCY AND AUDIT FEES UP

Accountancy fees were almost doubled from \$11,505 to \$22,411. This in part relates to NZPI's conversion to Xero and work requested by the Board in December. The Audit fee was also increased by almost \$3,000 which reflects an inflation adjustment.

COMPUTER SUPPORT AND EXPENSE

Computer support and expenses were up by c\$8,000. This was in large part due to the additional staff within the office and the conversion to ultra fast broadband to enable videoconferencing and reduce travel costs.

CONFERENCE IN QUEENSTOWN

Conference income was up from the previous year by around \$85,000 but so too were expenses by around \$87,000. The additional expenses were incurred by a combination of a large and diverse programme and the need for casual staff following the restructure in early 2014.

BOARD EXPENSES

Board expenses were also up by around \$6,000 reflecting an increase in the number of Board and Policy Advisory Committee (PAC) meetings in 2014.

CPD

CPD expenses were up, reflecting a year of investment but also CPD income exceeded the 2014 Budget by \$35,000.

EXPENSES NZPI RE BRANCHES

Expenses NZPI Branches were \$40,394. This line item reflects the Urban Design Forum expenditure of \$16,000 and PAC costs of \$24,000. UDF expenditure is included in our accounts but NZPI does not have access, ownership or control over the monies. With UDF's decision to establish itself as an independent entity, its accounts will be entirely separate and no longer be a part of NZPI's accounts going forward.

LEGAL FEES

Legal Fees were up in part due to the costs of restructuring and also legal advice sought on professional standards issues.

PUBLIC RELATIONS FEES

Public relations consultation fees were \$70,064. The Board did provide for \$40,000 to come forward from 2013, in addition to the 2014 budget of \$30,000. This has been included as a note in the financial report by the Accountants and represents an additional \$40,000 that should be subtracted from the end of year deficit.

SALARIES

Salaries were up against the 2014 salary budget, but largely as a reflection of the various times of the year the new staff joined and the additional employer kiwisaver obligations.

INCOME RECEIVED BUT NOT SHOWN IN 2014 ACCOUNTS

As noted in the annual statements NZPI receipted \$202,637 as income in advance in 2014. This has been reflected as an accrual in the current liabilities portion of the 2014 balance sheet reflected as monies collected for services to be provided in a subsequent year.

1. Statement of Accounting Policies

Reporting Entity

The New Zealand Planning Institute Incorporated is an Incorporated Society under the Incorporated Societies Act 1989 and is a reporting entity for the purposes of the Financial Reporting Act 1993.

The financial statements of the New Zealand Planning Institute Incorporated have been prepared in accordance with the Financial Reporting Act 1993.

Business

The principal activity is that of an incorporated body representing the professional planners in New Zealand. The Society represents the planners interest in the furtherance of planning, practice, maintenance of professional standards, dissemination of planning information and attending to the welfare of members.

Statement of Compliance and Basis of Preparation

The Financial Statements of the New Zealand Planning Institute Incorporated have been prepared in accordance with Generally Accepted Accounting Practice in New Zealand (NZ GAAP).

The Society qualifies for differential reporting as it is not publicly accountable and is not large as defined by the XRB A1 Accounting Standards Framework. The Society has taken advantage of all available differential reporting exemptions.

The accounting principles recognised as appropriate for the measurement and reporting of financial performance and financial position on a historical cost basis are followed by the Society.

Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of the Statement of Financial Performance and Statement of Financial Position have been applied:

(a) Revenue

Revenue is recognised to the extent that it is probable that economic benefit will flow to the entity and that revenue can be reliably measured.

(b) Trade Receivables

Trade Receivables are recognised at estimated realisable value.

(c) Property, Plant & Equipment

Property, Plant & Equipment are recognised at cost less aggregate depreciation. Depreciation has been calculated using the maximum rates permitted by the Income Tax Act 2007. Gains and losses on disposal of fixed assets are taken into account in determining the operating result for the year.

Office Equipment / 9 – 80.4% Website Costs / 48 – 60% Leasehold Improvements / 11.4 – 20%

(d) Income Tax

The income tax expense recognised in the Statement of Financial Performance is the estimated income tax payable in the current year, adjusted for any differences between the estimated and actual income tax payable in prior years.

(e) Goods and Services Taxation (GST)

Revenues and expenses have been recognised in the financial statements exclusive of GST except that irrecoverable GST input tax has been recognised in association with the expense to which it relates. All items in the Statement of Financial Position are stated exclusive of GST except for receivables and payables which are stated inclusive of GST.

(f) Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on a basis consistent with those from previous financial statements.
