Proposed Changes to NZPI's Membership Categories

The Board of NZPI has now concluded its consultation regarding the Membership Categories review and is asking Full Members of the Institute to vote on the necessary constitutional change that is needed to give effect to the proposed category amendments.

What are the proposed changes?

There are six proposed core changes to the constitution. What follows is the context in which each of those six constitutional changes have been proposed.

1) Technician Category

The Technician Category has just two members within it and membership of this category is contingent upon a qualification that no longer exists. It is therefore proposed that this category be removed from the Constitution effective 1 January 2016. Existing members of this category will continue to be recognised as Technician members, but no new applications for Technician category will be accepted.

2) Graduate and Intermediate Members

The Board has proposed a number of changes to the current Graduate membership category. These include:

- a) The proposal to have two classes for those who are graduates of accredited planning degrees. The two classes of membership will, if endorsed by the Full membership, be known as "Graduate" for graduates in their first two years of professional experience, and "Intermediate" for graduates with 3 to 6 years' professional experience.
- b) The proposal to require all Graduate and Intermediate members to undertake Continuing Professional Development (CPD).

 This doesn't require constitutional change but will be addressed via changes to the regulations later in the year. It is anticipated that Graduate members will be required to undertake 15 hours of CPD per annum, and Intermediate members will be required to undertake 25 hours of CPD per annum.
- c) The proposal to guide graduates through a pathway that culminates in full membership of the Institute. All graduates and intermediates will be encouraged and supported in their journey towards full membership via mentoring and CPD. It is proposed that intermediates be required to



apply for full membership of the Institute after six years of full time equivalent work within the planning profession as a Graduate/Intermediate, unless an extension of up to two years has been sought and granted. Such extensions shall be for special or exceptional circumstances. The provisions for an extension will be detailed in the regulations to enable the Board to ensure that the criteria and process for an extension can be modified or refined as necessary to support intermediate members in gaining full membership. If this requirement has not been met then the individual's membership of the Institute shall be deemed to have been terminated.

3) Non- Active and Retired Membership

It is proposed that the non-active and retired membership categories be moved to the regulations. This has two significant benefits, a) it reduces the overall number of current membership categories and b) provides the Board with the opportunity to review and revise both categories as required without needing to amend the constitution. For example, there has been throughout the consultative process a request to make the non-active category more flexible. This could be achieved if the category sits within the regulations.

4) Removal of Hon Fellow and Life Fellow

It is proposed that both of the above categories be removed from the Constitution and that the categories of Hon Member and Fellow be used to recognise those who have excelled. Existing Life Fellows and Hon Fellows will continue to be recognised as such, but no new Life or Hon Fellows memberships will be conferred.

5) Associates of the Institute

It is proposed that the wording relating to Associate membership be updated and that Associate not be titled 'members' but simply 'Associate'. It is considered that this change is necessary to address the current situation where many professional planners are using the Associate Member category as a default professional membership.

6) Free membership

It is proposed that the only members exempt from paying a subscription fee be students, existing Life Fellows and Honorary members.

Alignment within the Constitution – non-core changes



Whilst there are a number of other proposed changes to the Constitution they are largely semantic and required simply to a) align other clauses with the above fundamental changes, thereby creating consistency within the document or b) reflect a change in the way NZPI operates.

A sense of those non – core changes is provided below:

- 1) Clause 3.7 will be amended to reflect the smaller number of membership categories, becoming: 'member' where used alone or in the phrase 'member of the Institute' shall, unless a contrary interpretation appears, mean any Full Member, Graduate Member, Intermediate Member, Student member, Honorary Member or Fellow.
- 2) At times it is simply a matter of aligning the existing clause with a different number i.e. Clause 3.9 becomes aligned with Section 15.14.1 instead of 5.15.1.
- 3) Other amendments required relate to the deletion of clauses and/or the recognition that the clause will be dealt with via the regulations of the Institute.
- 4) And finally, some amendments are proposed to reflect changes in the way in which NZPI operates i.e. Clause 16.3 to become "notice of the AGM shall be posted or emailed to each member at least fourteen days prior to such meeting". Thereby reflecting that we now communicate largely online.

Majority rules

The NZPI Constitution rules that the outcome of the ballot be determined by the preferences of the majority of those Full Members who vote.

If agreed, when will the changes come into effect?

If the changes are endorsed by Full members of the Institute then they will come into effect on 1 January 2016, although applications for removed categories of membership will not be accepted after 1 May 2015. In the interim the Board will make the required changes to the NZPI Regulations and officers will be working hard to ensure that the transition to the new category framework is as smooth as possible.

When will the results of the ballot be announced?

It is anticipated that the Chair of the Board, Bryce Julyan, will announce the results of the ballot in April, 2015.

Thank you

On behalf of the Board of NZPI, I thank you for your patience and engagement throughout the review of the Membership Categories. The review has been challenging and has generated much healthy debate within the profession, especially around the issue of registration of the profession. For those of you who



have supported the notion of a Chartered Category, please be reassured that the Board will review this issue within the next two years but at this point, there is insufficient support to progress the concept.
