Julie commenced her career in planning at the Auckland City Council in 1994, coming to planning as a career via teaching. Julie moved to Waitakere City in 1994 where she project managed the hearing and decision-making processes for the Waitakere District Plan. She has extensive planning experience having worked in policy development, implementation and in the consents realm at both the district and regional levels. She is an accredited Hearing Commissioner and a highly effective and experienced Manager who has held senior management roles at the Auckland Regional Council, Auckland Council and now the Bay of Plenty Regional Council Toi Moana. She is currently the Policy and Planning Manager.

Julie has been involved in the development and implementation of the Auckland Regional Policy Statement, and district and regional plans in Auckland. She has also been involved in range of structure planning processes including the Oratia, Takanini and Long Bay Structure Plans and has a sound understanding of the importance of co-ordinated infrastructure co-provision and integrated management of complex environmental issues.
